In June, we were able to submit comments on the United States National Park Service proposal to update their service animal regulations, and on Ontario's proposal to update their Accessibility for Ontarians with Disabilities Act (AODA). We were able to mobilize some community members to submit comments as well, and we were specifically thanked by the AODA Reviewer for our comments.

- FAQ  
We are continuing to draft answers to common questions (FAQ) for the website, in sections, with the assistance of a community member. We have completed a preliminary "Laws" section, and are working on multiple other sections.

We are also planning on adding at least one page with responses from Pam Cohen, an attorney at Disability Rights California, to several questions submitted by our community.

- Articles  
We now have approval to use Tracey Martin's articles, with our editing. They have been edited and will be posted on our website soon.

We will be posting Veronica's "Interacting with the General Public" article on our website soon.

- Treasury Report

We discussed upcoming expenses and current funds, post-convention. The convention almost broke even with registration fees and half of the public access test fees, and our generous community members pushed us over the top with donations! Thank you. We have also received donations from outside of the community!

We are working on getting thank-yous out to donors.

- Nonprofit Status

The board is continuing to conduct research into the best way for us to create our nonprofit, and discussed nonprofit establishment timelines. A subcommittee was formed to promulgate these efforts.

- Emergency Contact Card

Community members at the convention voiced a desire for a PSDP emergency contact card, such as one that might be filled out with medical and contact information and attached to a dog's seat belt. We will provide this resource on our website in the near future, under "Service Dog Lifestyle".

- Needs Assessment

We plan to conduct another Needs Assessment Survey after the convention survey. Here are the previous survey's results, for review:

4.58 Providing written information about PSD costs and lifestyle  
4.49 Maintain information sharing listserv  
4.44 Providing a Public Access Standard and Public Access Test  
4.40 Providing a FAQ for the general public  
4.36 Providing a work and task list

31 nonprofit  
29 new listserv  
21 maintain listserv  
17 costs and lifestyle  
16 conventions

Aspects of and major decisions regarding such workshops are under discussion. We may also add pet CPR certification to our activities. This agenda item will be tabled until we are prepared for further discussion.

We are consolidating ideas for a membership program for the future. This item will be tabled until we achieve other priorities.
