2015 Convention

We have determined this and future conventions will be held between April and mid-May, so community members can start saving and planning for that time of year. The 2015 Convention Planning Committee is expected to announce the location and dates of this year's convention soon, pending contract signing and approval.

Needs Assessment

We are drafting our second Needs Assessment Survey. We plan to conduct these annually in September.

Website

-FAQ

We are continuing to draft answers to common questions (FAQ) for the website, in sections, with the assistance of a community member. There are no new completed sections since the last meeting, but Pam Cohen has contributed another section under the "Ask an Attorney" heading.

-Articles

Julia's article on how to pick a breeder of a prospective service dog has undergone editorial review and is awaiting approval before being published.

Treasury Report

We discussed upcoming expenses and current funds, including state incorporation fees and 501(c)(3) filing fees. We also discussed banking and 501(c)(3) status.

Opening an account at Rabobank as an unincorporated association was unanimously approved.

Nonprofit Status

A subcommittee is continuing to conduct research into the execution of steps toward state incorporation and federal 501(c)(3) status (nonprofit creation). Discussions are underway regarding the state of incorporation, research into the pertinent laws in the locales considered, and federal filing requirements.

The board approves the draft of bylaws presented during the meeting, as set forth for future incorporation in South Carolina, inasmuch as the intent and content of the bylaws can be applied before incorporation.
