Due to the busy nature of the business during the holidays, we are putting on hold the update on the nature of our relationship with Pup'parel. From last time:

In researching laws regarding commercial co-venturers, we have determined we would like to ask Pup'parel to continue to offer PSDP-logo products, but to cease providing any funds to us. In other words, we will not have Pup'parel as an official "co-venturer". We are still very happy with our relationship with Pup'parel—we plan to continue the non-financial portion of our relationship—and are only doing this in light of the filing requirements and fees required when an organization has a co-venturer, which seem to have been created only with larger organizations in mind. Unfortunately, for a small organization like ours, these additional requirements make it more a burden than it's worth to have a co-venturer.
