#### -Advocacy

The Department of Veterans Affairs (VA) has released a Proposed Rule regarding service animals on VA property. It is promising overall, and is consistent with PSDP's earlier interpretation of P.L. 112-154 and other federal regulations. However, there are some very important issues we need to speak up about so

we can safeguard the rights of our community. We have drafted a well-researched and powerful comment on the proposal, which we will release soon on our website and announce through social media. We will need our community's help by the January 20th deadline to be sure VA hears us!

#### -Hospitals

We are generating a sample hospital service dog policy and other resources to assist those who have service dogs and need to be in a hospital. Due to the interplay of such a policy with our comment on the VA's recently proposed rule, we relied on Chanda's research to help us draft our VA comment. One issue we completed a discussion on was the evaluation of the website organization in light of the pending creation of a "Hospitals" section for professional and personal guidance.

# •SD & SDIT state laws

We discussed the nature and applicability of state laws regarding service dogs and service dogs in training. We plan to do our best to host conventions only in states that support reasonable access for psychiatric service dogs in training.

### Treasury Report

We discussed upcoming expenses and current funds, the budget, earmarked funds, and fundraising.

## Nonprofit Status

A subcommittee is continuing to conduct research into the execution of steps toward state incorporation and federal 501(c)(3) status (nonprofit creation). The relevant forms have been filled out, and plans for incorporation in York County, South Carolina and subsequently filing for federal 501(c)(3) recognition are pending the relocation developments of board members. The three-page 1023EZ form, released by the IRS in July of this year, will make the 501(c)(3) application process much easier.

#### •2015 Convention

We have several registrations so far, with a maximum of 30 registrants, and the committee has almost finalized the schedule!

## • "Behavior, Not Belongings" Campaign

We are considering launching a "Behavior, Not Belongings" campaign, once we can prioritize it, based on this slogan we came up with in our statement entitled "There Are No Fake Vests". The aim would be to get our community and the public involved in educating gatekeepers in the U.S. not only on the relevant laws regarding service dog access, but on practical politeness toward service dog handlers—that is, on avoiding harassing/singling out a service dog handler, unless there is a clear reason to question the handler. We would also make it clear that there are specific conditions under which the handler of any dog, service dog or not, could be asked to remove their dog.

With this campaign, we would hope to make things easier for both gatekeepers and those with disabilities, so that both parties can move through the world while minimizing unnecessary interruptions. One method we are considering in achieving this aim is to conduct a social media and news media campaign to encourage people to pledge to print copies of a flyer or card we would create, and distribute a certain number of these to the management/employees of (at least) a certain number of businesses they frequent. Overall, we would be "Encouraging respect beyond the laws".

This campaign remains in the works, as we must prioritize other issues at the moment. We would be happy to make this a joint project with other service dog organizations.
