### •GuideStar Exchange

We are pleased to report that in July PSDP became a gold-level participant in the GuideStar Exchange, a program that encourages nonprofit accountability and financial responsibility. This certification will duly encourage savvy donors to comfortably contribute to further our mission.

SC NAMI Exhibition

Due to a recent surge in the generosity of our community and the public, we have been able to expand our in-person outreach and education efforts to include conference exhibitions. We are truly thankful to donors for making the practicalities possible! Veronica traveled to Columbia, South Carolina on August 15<sup>th</sup> to spend the day spreading the word at a state-level NAMI conference. It was very worthwhile, as several people were reached, and these leaders in the broader community are a perfect focus for PSDP resources to go viral throughout the state! As a measure of our success, we were able to distribute 145 outreach items!

Supporters interested in sponsoring future PSDP outreach activities should know that gifts are not only welcome, but needed. We have carefully budgeted costs to engage in specific future outreach events and have determined that \$1221 would cover at least two events, including reusables for future events. This calculation includes outdoor exhibition materials, such as a canopy, vendor fees to rent space at an event, printing costs for our popular and effective handouts, and minimal transportation and lodging costs for slightly farther than local events. We sincerely appreciate our donors' ongoing support, and we look forward to continuing to convert it into real impacts in people's lives!

### •Taxes

PSDP's fiscal year runs from July 1<sup>st</sup> to June 30<sup>th</sup>. PSDP's federal tax filing and state non-registration paperwork were filed right after the close of the fiscal year, at the beginning of July.

Anyone wishing to view PSDP's state non-registration paperwork may do so by requesting the paperwork via psdpinfo@gmail.com at any time. We did not post the state paperwork online because it is not of general interest (it doesn't provide significantly more information than the posted federal documentation), but we will honor any individual or corporation's request to see it via email.

# Advocacy Success

### Local transportation involvement

A representative from a Charlotte, North Carolina transportation administration set will be meeting with Veronica and Brad in Rock Hill, South Carolina on August 27<sup>th</sup> to learn more about (psychiatric) service dogs.

We developed Gatekeeper Guidance (and specifically Carolina Gatekeeper Guidance) to help the transportation operators and all other gatekeepers better understand service dog access. This will be posted under "Public Access" on our website, as well as under a future advocacy campaign community members will be able to participate in! We're excited to thereby revive our "behavior, not belongings" campaign idea to once again be "encouraging respect beyond the laws".

# -General

We've initiated Google Analytics on our site, which after the first month has informed us that our site receives approximately 10,000 visitors a month! This is a much larger impact than we thought we were making, so we're quite happy with the new data.

Additionally, we're able to learn more about the (anonymous) composition of our audience and their interaction with our site, so we can be sure to focus our efforts on things like being accessible on mobile devices—around half of our website visitors appear to access our site through such devices. Fortunately (and by purposeful design), we've earned the coveted new "Mobile Friendly" Google search designation, which is a contrast to our main keyword competitors and will move our search engine rankings up over time.

The activation of Google Analytics has also enabled us to deploy a left sidebar widget showing the top

five (non-homepage) pages on our site over the previous 31 days. This widget is useful for directing new visitors to content that has "clicked" with other visitors, which can help us get and keep people engaged with our resources so we can better fulfill our mission.

### -2015 FAQ Flyer, + Translation

We completed the 2015 update to our "Answers to Common Questions" flyer. We are beginning work toward translating the text into at least one other language in a multi-step process.

### -Work & Tasks

We have completed the editing process for PSDP's Work and Task List. We believe our 2015 list is now consonant with up-to-date theory, internally consistent, amenable to use by those with a greater breadth of mental illness symptoms and etiologies, etc. We are very proud of this popular resource!
