•WIOA regulation update

The Workforce Innovation and Opportunity Act (WIOA) regulations are being updated, including references to service animal access in places federally funded through WIOA. We will be submitting a comment and notifying the community about this feedback opportunity soon.

ACAA regulation update

We have posted a proposal detailing a system for the ACAA update. The proposal contains a form to be required for service dog accommodation in flight and a guidance brief explaining access in airports and airplanes.

We ran a survey (through Feb. 4th) asking community members what they think about the proposal, and how well it meets the six universal goals below. This will help us better represent everyone's interests going forward, in a way much more likely to lead to cooperation. We appreciate the excellent feedback we received, as we realize the effort and thought this took from the many community members who participated!

- Public safety through reasonable measures
- Fair and just disability access (mental health parity + no undue burden on disabled)

- Discouraging intentional and unintentional fraud
- Clarity and systematic ease of use for all parties
- Privacy of specific medical information
- Respect and liability reduction for airline and airport personnel as non-experts in disability access, animal behavior, and legal affairs

#### -General

We continue to have a growing impact each month since we've had the tools in place to keep track. One simple measure is the impressive number of pageviews our site has received...

July: 11,532

August: 12,869 (11.6% increase over July) September: 14,864 (15.5% increase over August) October: 16,684 (12.2% increase over September) November: 19,896 (19.3% increase over October)

November: 19,896 (19.3% increase over October)

December: 25,782 (29.6% increase over November, 123.6% increase over July—well more than double

within 6 months!)

January: 38,155 (48% increase over December)

We regularly work to improve our SEO (Search Engine Optimization) to increase our ability to reach those who need us. We have recently completed the process to enable site encryption and a security certificate, which is both good for our users and will increase our search rankings. This will not alter the user experience.

We are considering expanding the number of domain names that direct to our website, making it easier for people to find us.
