Board of Advisors

We are developing a Board of Advisors, and will likely have updates by around mid-June.

ACAA regulation update

The Reg Neg process to update the Air Carrier Access Act (ACAA) regulations is moving forward, and we are very pleased to report that Brad is a Co-Chair of the service animal working group, serving as the point-of-contact for service animal users in this six-month process!

This is an enormous opportunity for access improvements for the next generation. With continued support from our community, we'll keep working to represent service dog users' interests, building consensus around our proposal and honoring the reasonable concerns of all stakeholders.

Brad wrote a guide for regulators and stakeholders that explains the reasoning behind and justification for our ACAA proposal. This "design challenges and solutions" guide is available with a 5/1/16 addendum:

This guide has been serving as an excellent conversation-starter in the Reg Neg process, as other leaders are reading it and developing their views. We are working on refining our own views as we gain new information from other experts.

State legislative advocacy

We're continuing to make progress on our micro-advocacy development, making it easy for everyone to help out! This is planned in part as step-by-step instructions for community members to set up email alerts when bills about service dogs come up in a state.

South Carolina NAMI presentation

Brad and Veronica plan to present on psychiatric service dogs at the state NAMI conference in South Carolina in August.

ActiveDogs registry

ActiveDogs.com has come out with a service dog registry. We wrote an open letter to them explaining how this harms our community and asked them to take it down.

We haven't heard from them, and we're asking for community support in politely alerting them to the impact this will have on us and on their business (follow the link above). We sincerely hope they will work with us for a positive outcome.

•PSDP in the media

Sitting down in a half-hour interview filled with nuance and reason, PSDP's Dr. & Mr. Morris explained to a St. Louis reporter the complexities associated with the "fake service dog" phenomenon—such as the importance of avoiding knee-jerk lawmaking when something makes you angry. Their few-second clips in the 2 1/2 minute report coming out of this interview feature the times where each of them sound the most emotional!

On the upside, the reporter (KSDK's Kay Quinn) seemed to understand that encouraging a ban on the online sale of service dog gear was not the solution, leaving options open-ended in the mid-May release of this 2016 story.

We are still in the process of drafting a reply in "Dogs&Jobs" magazine to advise them about some inaccurate information in a recent issue, and generally about striving for accuracy in legal matters. We would not normally seek to correct every point of misinformation in the world regarding service dogs, but they specifically requested our input.

We are also drafting a first-responder refrigerator notice, and will be doing so based on the 2016 convention's first responder discussion.

Through June 6th, 2016, FAA has solicited comments on a new draft of their advisory circular, which contains recommendations to airports for the construction of SARAs (service animal relief areas). SARAs are mostly supposed to be provided within the secure area under the new guidance, which will be a great help to service animal users, pet owners, and TSA working dogs.
