• Air travel practicalities

DOT is renewing their OMB status on the service animal flying form (required for it to have legal effect), and they've slightly updated the form to clarify that owner-training is fine. We submitted a comment:

The National Federation of the Blind (NFB) petitioned the FAA to exempt blind guide dog users from the flying form. We are strongly against this anti-solidarity stance that encourages discrimination on the basis of disability. We appreciate our community members submitting comments to DOT about this, as we have. More information is on our advocacy page (linked above).

DOT plans to handle more substantive issues in the future, partly through their ACAA advisory committee. We'll have to ensure we have their ear before they draft an NPRM in this arena.

On a parallel advocacy track, DOT released an NPRM (notice of proposed rulemaking) with expansive protections for wheelchair users. Though it is not our area of expertise, PSDP is strongly supportive in general.
